Approval of this agreement is at the sole discretion of Rio Wraps Southwestern Grill. This agreement must be submitted three (3) weeks prior to your scheduled fundraising event. Either party outside of one week prior to event may terminate this agreement. The named organization will promote their event for the above named Rio Wraps Southwestern Grill. The proceeds for the event will be up to 20% of the pre-tax sales receipts for food and non-alcoholic beverages. It is of the decision of the designated Rio Wraps location to require a flyer for each transaction in which funds are donated. No other coupons or discounts will be applied. By signing this contract I understand that all flyers are to be distributed prior to the event, and under no circumstance are flyers to be handed out in the restaurant, parking lot or vicinity. The event typically takes place between the hours of 5 pm and 8pm unless otherwise approved and noted on the contract. A check will be mail to the organization within 3-5 weeks after the event. Either party hereto as the anticipated success of the event makes no guarantees or warranties of any kind.
